#### DEFERRED MEMBER EARLY RETIREMENT SUPPLEMENTAL ANALYSIS

Miss Munson reported that the Board is being presented with a copy of the supplemental actuarial analysis performed on the proposed early retirement program. The analysis was to determine the cost of offering an early retirement to certain deferred members of the Retirement System. She noted that this has come before the Board and the City Council once before. The cost to the Retirement System would be an additional \$7 million.

The proposed benefit would provide that designated members could begin receiving their pensions effective January 1, 2018, provided that the member has attained the age of forty-three. Members that have not attained the age of forty-three are still eligible to participate but not until they reach age forty-three.

GERS Special Meeting Minutes December 13, 2017 The supplemental analysis determined the effect that this change would have on the employer contribution. There is currently no required contribution from the employer due to the overfunding.
